

Dynamic Dollar-Cost Averaging Fund

Q&A

1. What is Dynamic Dollar-Cost Averaging Fund?

Dollar-cost averaging is an investment technique used to help reduce the risk of timing a single lump-sum investment. By investing a fixed dollar amount at regular intervals, the dollar-cost averaging process helps control the effect of market volatility by smoothing out the average cost per investment unit purchased. Over time, and in certain market conditions, it can result in a lower average price and a higher gain.

Dynamic Dollar-Cost Averaging Fund (DCAF) helps implement this technique by offering a sound, simple, and automatic way to invest in a variety of Dynamic funds.

Every week, 1/52 of the initial investment is transferred to the target Dynamic fund, with the balance remaining in DCAF. After 52 weeks, the initial investment is fully invested in the target fund.

The Fund invests primarily in fixed-income securities issued or guaranteed by the federal or provincial governments in Canada (or an agency thereof) with a maturity of not more than three years.

2. What are the benefits of using DCAF?

With DCAF, your clients get

Choice: Select from a wide range of Dynamic Funds.

Discipline and Peace of Mind: Because your client is continually investing – even in volatile markets – they stay focused on their long-term goals, without trying to time the markets.

Capital Protection: While waiting to be deployed, your client's capital is invested in safe fixed income securities.

3. What is the tax consequence to a non-registered account for holding units of the fund?

Investors holding units of DCAF will receive distributions, if any, when paid by the fund. Non-registered investors will receive a T3 tax slip reporting the amount of taxable distribution paid to them.

4. What are the fees charged and how are they charged?

The management fee on Series A is 1.00% and Series F is 0.50%. The fixed administrative fees are 0.17% and 0.12% respectively. More information on fees can be found in the Simplified Prospectus.

For the target fund, fees are charged as per the management fees outlined in the Simplified Prospectus, with discounts once the investor surpasses \$250,000 per account.

5. Can the 52-week timeframe be shortened or lengthened? (i.e. is it customizable?)

DCAF is a completely automated process built for the 52-week period and this timeframe is not customizable.

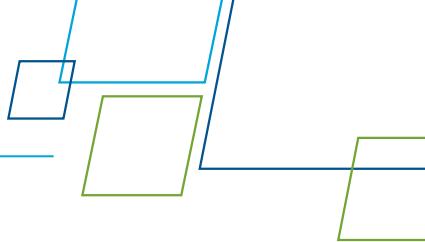
6. Are switches allowed from DCAF before the end of the 52-week period?

Full switch

- A full switch can be made at any time. If switching to another DCAF target fund, the 52-week schedule resets at week one of 52.

Partial switch

- A partial switch **cannot** be made from one DCAF target fund to another, i.e. DCAF Fund A to DCAF Fund B.
- A partial switch **can** be made from DCAF to non-DCAF. The remaining balance in DCAF will continue to be switched to the original DCAF target fund for the same dollar amount, effectively reducing the 52-week timeframe.



7. For an investor with assets already in DCAF (ex. 6 months remaining on the DCAF schedule). What happens if an additional investment is made into DCAF?

A new 52-week DCAF schedule begins for the new investment and the existing DCAF schedule will complete its remaining 6 months as scheduled. This will be the case whether the target fund is the same or different.

8. Are short-term trading fees applied to switches to the target fund?

Short-term trading fees are not applicable to DCAF.

9. How does the redemption schedule work for Low Load and Low Load 2 funds?

The maturity date of the units carry over to the target fund. The redemption schedule follows the initial purchase that was made into DCAF.

10. How does DCAF appear on a statement?

The following statement snapshots consist of a small sample of account and transactional information you can expect to receive in a client-name statement containing DCAF investments.
