Risk-Aware, Long-Term Focus

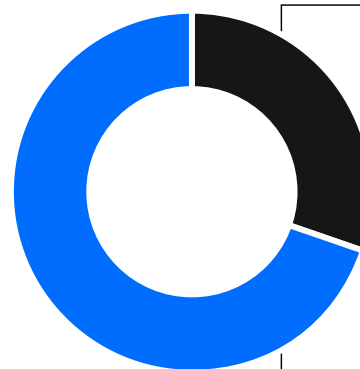

Value-Oriented Portfolio

The Fund is built using a value-oriented approach. It provides Canadian investors access to opportunities beyond traditional dividend mandates and benchmark-driven strategies. Designed to reward patience, this strategy aims to deliver attractive long-term outcomes.

Core anchors and high conviction alpha positions



Historically, **30%** of the portfolio is invested in undervalued, overlooked, or misunderstood companies that are less likely to be in a traditional dividend fund; i.e., unique bottom-up opportunities

Historically, **70%** of the portfolio is invested in high-quality, dividend-paying Canadian companies; i.e., banks, insurance companies, railroads, and pipelines
