Highlights

Credit Dispersion

November credit spreads offered a first glimpse of modest dispersion since the wild “Liberation Day” dislocation event earlier this year. At the index level, investment grade and high yield credit spreads traded within a range of approximately 5bps and 25 bps respectively. Both asset classes closed the month towards the tighter end of recent ranges as investors looked forward to the potential of more accommodative central bank policy in the near-term.

Beneath the surface, it was a different story with trading activity in lower-rated credits exhibiting growing signs of caution. Bonds rated CCC underperformed during the month as investors shied away from the riskiest debt, driven partly by frayed nerves coming from recent bankruptcies and fraud-related headlines in the previous month, which have added a layer of uncertainty around credit quality. Highly levered credits in higher-beta sectors such as Building Products and Chemicals led the sell-off as earnings in both sectors continue to be negatively impacted by low demand and overcapacity. Credit in riskier companies owned by private equity also underperformed. Credit spreads in AI-related issuers in the Technology sector also widened, as massive debt-financed spending in AI and cloud computing infrastructure sparked investor concerns regarding a risky mix of over-spending coupled with over-leveraged balance sheets.

November proved to be a balancing act: optimism from rate cuts and accommodative central bank policies was offset by growing concerns in lower-rate and riskier credit, setting up a credit market tone that is cautiously optimistic but keenly aware of shifting risks. Our defensive positioning worked well across the mandates as we have avoided riskier credits, more economically sensitive sectors, and over-leveraged balance sheets. We added modest exposure to our favorite lines during the month and are evaluating opportunities in higher-beta issuers where the recent selloff has shifted valuations more in our favour.

Portfolio Updates

Ultra-Short Term Investment Grade Mandates:

- Continued to focus on high-quality issuers that provide stability and predictable cash flows.
- Focused on investing in 2-3 years maturities given tight credit spreads and flat credit curve.
- Increased the Fund's weight in short duration securitized products at attractive spreads.
- Yield generated by the portfolio is 3.09%, well above overnight rate in Canada at 2.25%.
- Well-positioned to provide competitive yields relative to cash-equivalent alternatives—including HISA and GIC—while maintaining daily liquidity.

Discounted Investment Grade Mandates:

- Average bond price of \$94.74 for the US mandate and \$99.60 for the Canadian mandate. Discounts versus benchmarks were close to \$3.50 for both mandates highlighting the strategy's inherent tax awareness.
- Took advantage of attractively priced new issues in the Canadian mandate to generate additional alpha.
- Increased our weight in US treasuries in the US mandate.

Multi-Sector Fixed Income / High Yield Mandates:

- Continued to maintain defensive positioning relative to benchmarks with credit selection efforts focused on higher quality issuers with stable earnings and strong credit profiles.
- Took profits in select Canadian High Yield names where valuations had become stretched and upside convexity was largely non-existent.
- Purchased high quality US High Yield issuers where valuations had sold off, adding to certain existing positions at attractive levels and entering into new positions for issuers we have been monitoring for a while, where valuations finally reached levels skewed in our favor.

Preferred Share Mandates:

- Continued to pick away at LRCNs, Institutional preferred shares and hybrids given their more attractive medium-term risk-reward profiles. \$CAD 25 preferred shares represent less than 80% of the portfolio.
- Delivered strong relative and absolute performance year-to date.
- Supporting the preferred share market: 1) redemptions larger than new issuance flows and 2) resilient credit spreads

Liquid Alternatives Mandates:

- **Dynamic Credit Absolute Return Fund**

- Increased slightly the portfolio's credit exposure by purchases of specific issuers on the primary market and Canadian Bank LRCN while reducing expensive short dated corporate bonds to reduce leverage.
- Benefited from an early takeout surprise in the bonds of MEG Energy which were taken out at a significant premium to par following the closing of Cenovus' acquisition of MEG during the month.
- Raised short-duration securitized products exposure. This allocation provides enhanced diversification and incremental yield for investors without taking too much risk. The monthly prepayment profile enhances the portfolio's overall liquidity.
- Continued to increase the allocation to short-duration, yield-to-call high yield bonds issued by well-capitalized borrowers, capturing opportunities that offer attractive carry and favorable optionality.

- **Dynamic Credit Opportunities Fund**

- Benefited from an early takeout surprise in the bonds of MEG Energy which were taken out at a significant premium to par following the closing of Cenovus' acquisition of MEG during the month.
- Our position in Greenfire's 12% 2028 bonds will be called at a massive \$6 premium to par in mid-December following the company's recently announced rights offering with proceeds used to delever the balance sheet. This successful investment reflects the type of attractively priced "off-the-run" opportunities that our in-depth, bottom-up research process can identify.
- During the month, we took modest sales within our Relative Value strategy in issuers where valuations were no longer attractive and upside was constrained.
