**What does the Fund invest in?**

The Fund invests primarily in a diversified portfolio of equity and fixed-income mutual funds.

**How risky is it?**

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

**Risk rating**

1832 Asset Management L.P. has rated this Fund's risk to be **low to medium**.

This rating considers how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

**No guarantees**

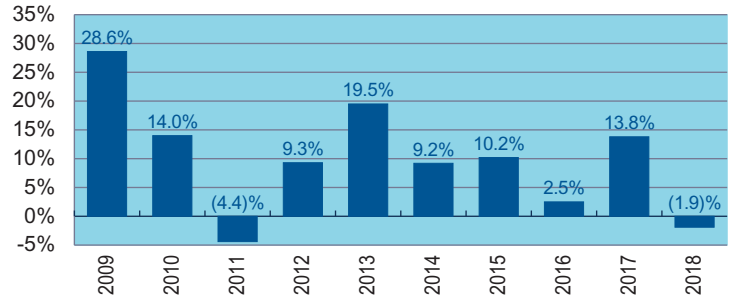
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

**How has the Fund performed?**

This section tells you how the Series IT units of the Fund have performed over the past 10 calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

**Year-by-year returns**

This chart shows how the Series IT units of the Fund have performed in each of the past 10 calendar years. The Fund dropped in value in 2 of the past 10 calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



**Best and worst 3-month returns**

This table shows the best and worst returns for the Series IT units of the Fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

**Average return**

A person who invested \$1,000 in Series IT units of the Fund ten years ago now has \$2,346. This works out to be an annual compound return of 8.9%.

**Who is this Fund for?**

**Investors who are ...**

- seeking a balance of capital growth potential and income from a portfolio invested in equity and fixed-income mutual funds;
- looking for the convenience of a diversified portfolio in a single fund that invests in other mutual funds;
- able to accept some variability of returns and are investing for the medium to long term.

Series IT units are intended for investors making large investments in a Fund and seeking stable monthly distributions.

**!** Do not invest in this Fund if you are seeking aggressive growth of capital through an equities only investment strategy.

**A word about tax**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell Series IT units of the Fund. The fees and expenses, including any commissions, can vary among series of the Fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**

No sales charges are applicable to the Series IT units of the Fund.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the returns of the Series IT units of the Fund.

As of June 30, 2019, the Series IT units of the Fund's expenses were 0.25% of its value, which equals \$2.50 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of the Series IT units of the Fund's fixed administration fees and fund costs.	0.14%

**More about the trailing commission**

No trailing commissions are applicable to the Series IT units of the Fund.

**3. Other fees**

You may have to pay other fees when you buy, hold, switch, redeem or reclassify units of the Fund.

<b>Fee</b>	<b>What you pay</b>
<b>Switch fee</b>	This fee is negotiated with and paid to your representative's firm to a maximum of 2% of the value of units you switch to another fund.
<b>Short-term trading fee</b>	If you redeem or switch securities within 30 days of purchase or switch we may charge a short-term trading fee of 1% of the net asset value of the securities you redeem or switch. We monitor trading activity for up to 90 days. If we identify multiple redemptions or switches within 90 days we may charge 1% of the net asset value of the securities you redeem or switch. This fee is paid to the Fund and is in addition to any switch fee that is payable by you to us.
<b>Management fee</b>	Management fees are paid directly by you to 1832 Asset Management L.P. The management fee for Series IT units of the Fund is up to 0.90%.
<b>Dealer fee</b>	You may pay a separate fee to your representative's firm, which is negotiated between you and your representative.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy units of the Fund within two business days after you receive a copy of the Fund's simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
