

1832 Asset Management L.P.

This document contains key information you should know about Dynamic Energy Income Fund (the "Fund"). You can find more detailed information in the Fund's simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

Effective May 8, 2020, the Series G units will be consolidated on a 5:1 ratio. Unitholders will be entitled to receive one consolidated unit of the Fund for every five units of the Fund they own on that date. The fund codes will be updated to FE: DYN4430G, DSC: DYN4433G, LL: DYN4432G. The Series G units are no longer generally offered by this Fund but units of this series remain outstanding from prior issuances and additional units may be issued to permit for switches by existing investors from this series of the Fund into the same series of a different Fund.

What does the Fund invest in?

The Fund invests primarily in equity securities of Canadian companies involved in energy-based or alternative energy activities. Up to 49% of the Fund's assets may be invested in foreign securities.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

1832 Asset Management L.P. has rated this Fund's risk to be **medium**.

This rating considers how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

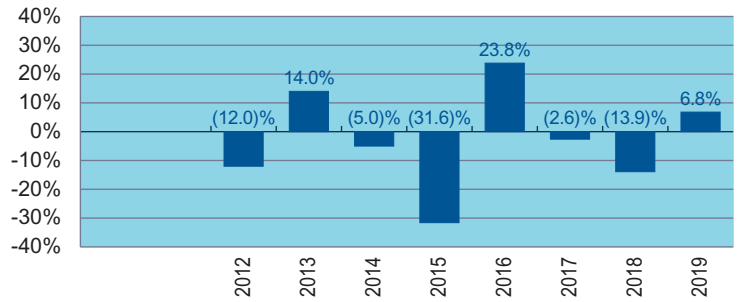
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how the Series G units of the Fund have performed over the past 8 calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This chart shows how the Series G units of the Fund have performed in each of the past 8 calendar years. The Fund dropped in value in 5 of the past 8 calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for the Series G units of the Fund in a 3-month period over the past 8 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series G units of the Fund when it was created now has \$477. This works out to be an annual compound return of -7.7%.

Who is this Fund for?

Investors who are ...

- seeking the income and capital growth potential in equities of energy based or alternative energy based businesses;
- able to accept some variability of returns and are investing for the long term.

Series G units are intended for investors resident in a province or territory of Canada in which the HST does not apply.

! Do not invest in this Fund if you cannot accept the volatility of equity markets.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series G units of the Fund. The fees and expenses, including any commissions, can vary among series of the Fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You have to choose a sales charge option when you switch into the Fund from Series G of a different Fund. Ask your representative about the pros and cons of each option.

Under the annual free redemption feature, each calendar year you may redeem up to 10% of your investment without paying the deferred sales charge.
Low load sales charge	<i>If you redeem:</i> During first 18 months, 3.0% Between 19 and 36 months, 2.0% Thereafter, nil	\$0 to \$30 on every \$1,000 you redeem	If you choose a low load sales charge option when you switch into the Fund from a series previously acquired on a low load sales charge basis, a sales charge may be payable by you depending on when you redeem or switch your units. If you switch your units, the new securities issued to you will continue to be subject to the same deferred sales charge. The charge is based on the net asset value of those securities at the time of redemption and is deducted from the amount you redeem. Any deferred sales charge you pay goes to 1832 Asset Management L.P. You will not pay a charge unless you redeem your units within three years of buying them.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the Series G units of the Fund.

As of December 31, 2019, the Series G units of the Fund's expenses were 2.09% of its value, which equals \$20.90 for every \$1,000 invested.

Management expense ratio (MER)

This is the total of the Series G units of the Fund's management fees (which includes the trailing commission), fixed administration fees and fund costs.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and/or advice your representative and their firm provides to you.

1832 Asset Management L.P. pays the trailing commission to your representative's firm. It is paid from the Fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose:

Front-end sales charge: 0% to 1.00% of the value of your investment each year. This equals \$0 to \$10.00 each year for every \$1,000 invested.

Deferred sales charge: 0% to 0.50% of the value of your investment each year. This equals \$0 to \$5.00 each year for every \$1,000 invested.

Low load sales charge: 0% to 0.50% of the value of your investment each year for the first three years, and thereafter 0% to 1.00% of the value of your investment each year. This equals \$0 to \$5.00 each year for the first three years for every \$1,000 invested, and thereafter \$0 to \$10.00 each year for every \$1,000 invested.

3. Other fees

You may have to pay other fees when you buy, hold, switch, redeem or reclassify units of the Fund.

Fee **What you pay**

Switch fee

This fee is negotiated with and paid to your representative's firm to a maximum of 2% of the value of units you switch to another fund.

Short-term trading fee

If you redeem or switch securities within 30 days of purchase or switch we may charge a short-term trading fee of 1% of the net asset value of the securities you redeem or switch. We monitor trading activity for up to 90 days. If we identify multiple redemptions or switches within 90 days we may charge 1% of the net asset value of the securities you redeem or switch. This fee is paid to the Fund and is in addition to any sales charge or any switch fee that is payable by you to us.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy units of the Fund within two business days after you receive a copy of the Fund's simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
