What does the Fund invest in?

The Fund invests primarily, directly or indirectly, in gold and/or equity securities of issuers engaged in the exploration, development or production of gold. The charts below provide you with a snapshot of the Fund's investments on September 30, 2019. The Fund's investments will change.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

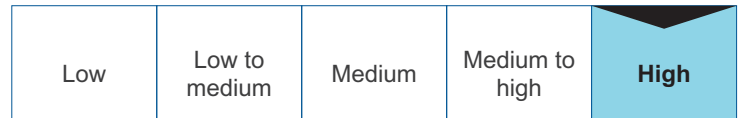
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

1832 Asset Management L.P. has rated this Fund's risk to be **high**.

This rating considers how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

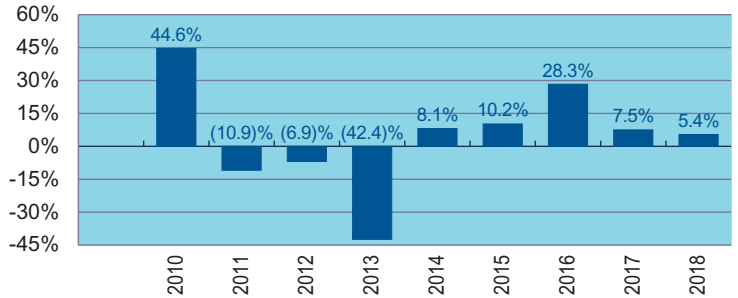
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how the Series I shares of the Fund have performed over the past 9 calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This chart shows how the Series I shares of the Fund have performed in each of the past 9 calendar years. The Fund dropped in value in 3 of the past 9 calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for the Series I shares of the Fund in a 3-month period over the past 9 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series I shares of the Fund ten years ago now has \$1,495. This works out to be an annual compound return of 4.1%.

Who is this Fund for?

Investors who are ...

- seeking exposure to the gold and precious metals sector;
- are seeking a tactical approach to investing in gold bullion and gold equities concurrently;
- able to accept some variability of returns and are investing for the medium to long term.

Series I shares are intended for investors making large investments in a Fund.

! Do not invest in this Fund if you cannot accept the volatility of gold and gold equities.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

A switch to a different fund within the same mutual fund corporation or a reclassification between series of the same fund that employ different hedging strategies will result in a disposition for tax purposes and accordingly, you will realize a capital gain or capital loss.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series I shares of the Fund. The fees and expenses, including any commissions, can vary among series of the Fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

No sales charges are applicable to the Series I shares of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the Series I shares of the Fund.

As of June 30, 2019, the Series I shares of the Fund's expenses were 0.18% of its value, which equals \$1.80 for every \$1,000 invested.

Management expense ratio (MER)

This is the total of the Series I shares of the Fund's fixed administration fees and fund costs.

No trailing commissions are applicable to the Series I shares of the Fund.

3. Other fees

You may have to pay other fees when you buy, hold, switch, redeem or reclassify shares of the Fund.

| Fee | What you pay |
|-------------------------------|---|
| Switch fee | This fee is negotiated with and paid to your representative's firm to a maximum of 2% of the value of shares you switch to another fund. |
| Short-term trading fee | If you redeem or switch securities within 30 days of purchase or switch we may charge a short-term trading fee of 1% of the net asset value of the securities you redeem or switch. We monitor trading activity for up to 90 days. If we identify multiple redemptions or switches within 90 days we may charge 1% of the net asset value of the securities you redeem or switch. This fee is paid to the Fund and is in addition to any switch fee that is payable by you to us. |
| Management fee | Management fees are paid directly by you to 1832 Asset Management L.P. The management fee for Series I shares of the Fund is up to 1.00%. |
| Dealer fee | You may pay a separate fee to your representative's firm, which is negotiated between you and your representative. |

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy shares of the Fund within two business days after you receive a copy of the Fund's simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
