# **Investment Objective and Strategies**

The Fund seeks to achieve long-term capital growth by investing primarily in global equity and fixed income securities.

This Fund represents an actively traded portfolio of global equity and fixed income securities. This approach seeks to identify companies demonstrating better than average current or prospective earnings growth relative to the overall market and relative to their peer group. The fixed income component is invested primarily in global government bonds and is actively traded in response to movements in the level of bond yields and the shape of the yield curve.

All of the Fund's objectives and strategies are further described in the simplified prospectus of the Fund.

# Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

# **Results of Operations**

For the year ended at June 30, 2024 (the "period"), the Series A shares of the Fund generated a total return of 7.5%. Fund returns

are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmarks, the MSCI World Index (C\$) and the J.P. Morgan Global Government Bond Index (C\$), returned 24.2% and 1.8%, respectively, during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 50% MSCI World Index (C\$) and 50% J.P. Morgan Global Government Bond Index (C\$), returned 12.6% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

To achieve its long-term asset allocation mandate, the Fund invested directly in fund(s) managed by the Manager or by third party investment managers ("Underlying Fund(s)"). As a result, the following commentary on investment portfolio activity relates to the Underlying Fund(s). Commentary on income, expenses and shareholder activity relate to the Fund.

The Fund underperformed the blended benchmark during the period due primarily to stock selection in the Information Technology and Financials sectors. Not owning any Consumer Staples companies was a key positive for relative performance as the sector was the worst performer for the benchmark. From a regional standpoint, companies from the U.S. were significant contributors to Fund performance, while companies from the Netherlands were the biggest detractors. The Fund holds shares of the Dynamic Canadian Money Market Fund which outperformed the J.P. Morgan Global Government Bond Index (C\$) during the period.

Global equities advanced over the 12-month period as the MSCI World Index (C\$) returned 24.2%. As we witnessed equity markets generate double-digits returns, inflation has declined and the global economy has remained stagnant (slow growth). This has put the spotlight on central banks on the likelihood and extent of interest rates cuts.

The Bank of Canada (BoC) was the first Group of Seven central bank to offer rate relief with a 25 basis point interest rate cut. This was soon followed by the European Central Bank (ECB) with also a 25 basis point cut. Both central banks indicated additional reductions were possible even though inflation remains above their targets because they expect inflation to keep declining.

The U.S. Federal Reserve (Fed) has taken a wait and see approach on reducing interest rates. The basis for this stance is that inflation remains stubbornly above the Fed's 2% target inflation rate. As of May, the inflation rate came in at 3.3%. The Fed is trying to balance the risk of cutting rates too soon and allowing inflation to persist. Fed Chair Powell mentioned they can take their time to cut interest rates so long as the labor market stays healthy.

Ironically, the Bank of Japan raised interest rates from -0.1% to +0.1%, ending the eight-year era of negative interest rates. The Japanese economy, which faced deflationary pressures for a prolong period, now see indications of healthy inflation in recent months.

This high interest environment has been able to tame inflation but resulted in stagnant economic growth in most regions around the world. In the second half of the year, we are likely to see central banks take more decisive steps in cutting interest rate cuts to avoid an economic contraction.

Ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 12-month period, with Information Technology, Communication Services and Financials being the largest contributors to index returns. The worst performing sectors were Real Estate, Consumer Staples and Utilities.

The Canadian bond market, as represented by the FTSE Canada Universe Bond Index, finished up 3.7% for the 12-month period ending June 30, 2024, as central banks paused their hiking cycles and began to reverse course. The 10-year Government of Canada yield reached its highest level in 16 years in October before falling into the year-end. 2024 saw the 10-year yield drift upwards before falling on central bank action in June. During the period the Bank of Canada (BoC) raised its policy rate by 25 basis points (bps) in July, then went on to pause rate hikes for almost twelve months before announcing a 25 bps cut in early June of 2024. This was the first rate cut by the BoC in four years. Within the U.S., the 10-year Treasury yield similarly trended upwards into October before dropping sharply. The Federal Reserve hiked rates once in July but then held its key rate steady at 5.25–5.50% for the remainder of the period.

Investment grade and high yield credit spreads, as measured by ICE BofA Canadian and U.S. corporate indices OAS (Option-Adjusted Spread) rallied at the start of the period before widening in October amidst the crisis in the Middle East. Spreads then narrowed from November into the end of the period.

The Canadian money market yield curve flattened and moved down. The one-month T-bill rate decreased 8 basis points to 4.68% and the one-year T-bill yield decreased 70 basis points to finish the quarter at 4.43%. The one-month / one-year spread narrowed to 25 basis points at the end of the period. The overnight CORRA rate declined 5 basis points to 4.80%.

The stock market of the past 12 months hasn't fully rewarded the new leadership of growth stocks but instead the slower single digit plodders in the mega cap technology space. During the period, the Magnificent Seven stocks (Nvidia, Microsoft Corporation, Amazon.com, Inc., Meta Platforms Inc., Alphabet, Inc., Apple Inc. and Tesla), contributed nearly 40% of the return of the MSCI World (C\$) index and that is with Tesla detracting approximately

32 bps from the return. Perhaps a preference for buybacks, operating leverage and underweighting in the sector is to blame. Yes, some of the mega cap stock moves were justified, as several of these companies have had positive inflections in their businesses, but many of the past year's leaders simply didn't meet our growth thresholds that have we followed for the past 30 years; however; we believe a major inflection point has arrived.

After laying people off and cutting costs, the mega-cap technology companies are embarking on a massive AI related capital expenditure plan. Microsoft alone will spend well over \$40 billion dollars over the near term on AI datacentres and infrastructure. \$40 billion is a larger dollar amount than 80% of the companies in the S&P 500 have in annual revenue. Many of these mega-cap names have been trading off the tremendous operating leverage they've seen through cost cutting and layoffs. That era is coming to an end.

We believe that the bigger opportunity today for investors is in the next generation of companies of technology companies. We see a very long runway ahead for the cloud, driven by continued digital transformation with AI-based business transformation, including automation and analytics being layered on top. All of this is being built on a new modern technology architecture in which we have significant investments. Many of these companies will be direct beneficiaries of more data in the cloud and "free riders" of hyperscale capex – reaping the benefits but not spending the money. For this cohort of companies, we see accelerating topline growth off already high bases and significant operating leverage as they are untethered from increased costs and are direct beneficiaries of the demand it brings. We are very excited about what lies ahead.

At the end of the period, the Fund was comprised of companies from the Information Technology, Consumer Discretionary, Communication Services, Financials and Health Care sectors. In most reporting periods, stock selection in the Information Technology sector has been a positive for relative performance and has been a key driver of the Fund's long-term returns. During the past twelve months, stock selection in the sector detracted from relative performance; however, the Fund's Information Technology holdings were significant positive contributors to absolute performance. Five of the Fund's holdings from the Information Technology sector were among the top ten detractors from Fund performance. One of those companies wasn't held by the benchmark. Six Information Technology companies were among the Fund's top ten stock contributors. Four of the top ten stock contributors to benchmark performance were Information Technology companies. Only one of those companies met the Fund's growth investment criteria and was held during the period. None of the benchmark's Financials holdings were notable contributors or detractors to performance. One of the Financials companies held by the Fund, was a key detractor from performance. The benchmark also held the stock, but in such a small weighting that it was not a notable detractor from performance.

The shares of the Dynamic Canadian Money Market Fund that were held during the period had performance enhanced by a modest extension of average term, while still maintaining a lower average term relative to the FTSE Canada 91 Day T-Bill Index to enhance liquidity. Performance was also enhanced by floating rate note positions. Floating rate notes have historically provided a yield pick up relative to bankers' acceptances and commercial paper. The yield of the Dynamic Canadian Money Market Fund shares was higher than the FTSE Canada 91 Day T-Bill Index benchmark and the yield increased relative to the prior period.

Notable changes to the Fund's equity sector allocation during the past six months included an increase in the Consumer Discretionary and Financials sectors and a decrease in the Health Care sector weighting. At the start of the period, the Fund did not own any Financials sector companies. From a regional standpoint, the Fund owned positions in China and Taiwan and neither country was held by the Fund at the start of the period. The weighting of several countries went to zero, as the positions from those countries were exited. Sector and country weights in our Portfolio are derived strictly from our bottom-up stock selection process.

We employ a disciplined, repeatable, and proven investment process that focuses on a bottom-up stock selection approach. This process leads us to building concentrated portfolios of 20–25 companies. Our investment process begins by screening the universe of all publicly listed companies to seek out those with high revenue growth, high earnings growth and the ability to become significantly larger companies over time. Companies included in benchmarks are there solely due to capitalization size and not due to any fundamental or qualitative factors. We are active stock pickers. The universe of stocks available for inclusion in our portfolios is limited to those that meet our investment criteria, not to those contained in the benchmark. We do not concern ourselves with what companies are held in the benchmark and as a result, our portfolios are very different from their benchmarks. It is our job to beat the index over time, not be the index.

The Fund's net asset value decreased to \$288.0 million at June 30, 2024, from \$362.7 million at June 30, 2023. This change was composed of net redemptions of \$98.0 million, cash distributions of \$0.5 million and investment performance of \$23.8 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

## **Recent Developments**

There have been no recent developments that have affected, or are likely to materially affect the Fund.

## **Related Party Transactions**

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

## Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pays the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

#### Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

#### Performance Fees

The Manager is entitled to an annual performance fee based on the performance of the Fund as compared to the performance of a benchmark, as described in the Fund's simplified prospectus. Performance fees are calculated on a calendar year basis.

## **Distribution Services**

Certain registered dealers through which shares of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

#### Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when shareholders switch between series of funds denominated in different currencies.

#### Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;

- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

## **Management Fee**

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.








