The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund seeks to provide long-term capital growth through investment in a broadly diversified portfolio consisting primarily of equity securities of businesses located around the world.

To achieve its mandate, the Fund will invest primarily in equity securities that have current or anticipated dividend policies which the portfolio advisor believes are an indicator of long-term growth potential.

The Fund generally uses a "value investment approach". Investment analysis for the Fund follows a bottom-up approach, which emphasizes careful company specific analysis. Using a value investment approach, the Fund invests in companies that represent good value based on current stock price relative to the company's intrinsic value.

All of the Fund's objectives and strategies are further described in the simplified prospectus of the Fund.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at June 30, 2024 (the “period”), the Series A units of the Fund generated a total return of 20.6%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund’s benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the “Past Performance” section for the performance of the Fund’s other series.

The Fund’s broad-based benchmark, the MSCI World Index (C\$), returned 24.2% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund’s performance relative to the general performance of the market.

The Fund underperformed the benchmark primarily due to stock selection in the Industrials and Financials sectors. Stock selection in the Health Care sector was a key positive for relative performance. From a regional standpoint, companies from the U.S. were by far the main contributors to performance followed by Denmark. There weren’t any countries whose companies were notable detractors from Fund performance.

Global equities advanced over the 12-month period as the MSCI World Index (C\$) returned 24.2%. As we witnessed equity markets generate double-digit returns, inflation has declined and the global economy has remained stagnant (slow growth). This has put the spotlight on central banks on the likelihood and extent of interest rates cuts.

The Bank of Canada (BoC) was the first Group of Seven central bank to offer rate relief with a 25 basis point interest rate cut. This was soon followed by the European Central Bank (ECB) with also a 25 basis point cut. Both central banks indicated additional reductions were possible even though inflation remains above their targets because they expect inflation to keep declining.

The U.S. Federal Reserve (Fed) has taken a wait and see approach on reducing interest rates. The basis for this stance is that inflation remains stubbornly above the Fed’s 2% target inflation rate. As of May, the inflation rate came in at 3.3%. The Fed is trying to balance the risk of cutting rates too soon and allowing inflation to persist. Fed Chair Powell mentioned they can take their time to cut interest rates so long as the labor market stays healthy.

Ironically, the Bank of Japan raised interest rates from –0.1% to +0.1%, ending the eight-year era of negative interest rates. The Japanese economy, which faced deflationary pressures for a prolong period, now see indications of healthy inflation in recent months.

This high interest environment has been able to tame inflation but resulted in stagnant economic growth in most regions around the world. In the second half of the year, we are likely to see central banks take more decisive steps in cutting interest rate cuts to avoid an economic contraction.

Ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 12-month period, with Information Technology, Communication Services and Financials being the largest contributors to index returns. The worst performing sectors were Real Estate, Consumer Staples and Utilities.

At period end, the Fund was comprised of seven of the eleven sectors of the MSCI World Index (C\$). If we do not like companies in a particular sector, we will zero weight the sector. Throughout the period, the Fund did not own any Real Estate or Utilities companies, which was a positive for relative performance as they were among the three worst performing sectors for the benchmark.

During the period, the Fund had overweight exposure to the Industrials sector as the sector is an area where we found several opportunities. The Fund’s Industrials holdings were positive contributors to absolute performance; however, they detracted from relative performance. The key reason for this was that long-time holding Schweiter Technologies AG, (a positive contributor to performance over the time it has been held), was the second biggest stock detractor from Fund performance. The stock was not held by the benchmark. Caterpillar Inc. was also a key detractor from Fund performance. No Industrials companies were notable detractors from benchmark performance. Schweiter Technologies AG remained in the Portfolio at period end. The position in Caterpillar Inc. was exited. The Fund’s Financials holdings were the fourth best sector contributors to performance on an absolute basis but detracted from relative performance. Of the twelve Financials stocks held by the Fund during the period, only three detracted from performance and none of those were notable; however, the collective Financials holdings of the benchmark, outperformed those of the Fund.

Led by top five stock contributors Eli Lilly and Company and Novo Nordisk A/S, the Fund’s Health Care companies outperformed those of the benchmark. Both stocks were also key drivers of benchmark performance. However, the weighting of the stocks in the Fund were much larger than in the benchmark, which led to the stocks’ contribution to Fund return being more than triple that of the benchmark.

Notable changes to the Fund’s sector allocation during the past twelve months were an increase in the Communication Services and Financials sector weightings and a decrease in the Health Care sector weighting. Notable changes to the geographic allocation included a significant increase in the U.S. weighting and decreases to Israel, Switzerland, France and the U.K. and all positions from the latter two countries were exited during the period. Changes to regional and sector allocations are the result of the bottom-up investment process.

The Fund’s net asset value decreased to \$5.1 billion at June 30, 2024, from \$5.4 billion at June 30, 2023. This change was composed of net redemptions of \$1,299.6 million, cash distributions of \$8.3 million and investment performance of \$978.9 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund’s income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund’s income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pays the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$43,000 in commissions to Related Brokers.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for

securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of

such securities and the 60-day period following the completion of such distribution;

- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

Financial Highlights

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fee

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

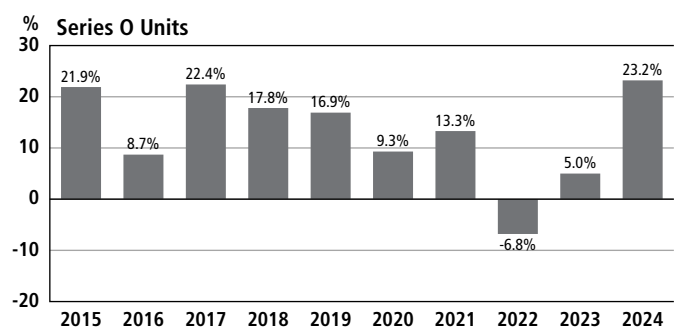
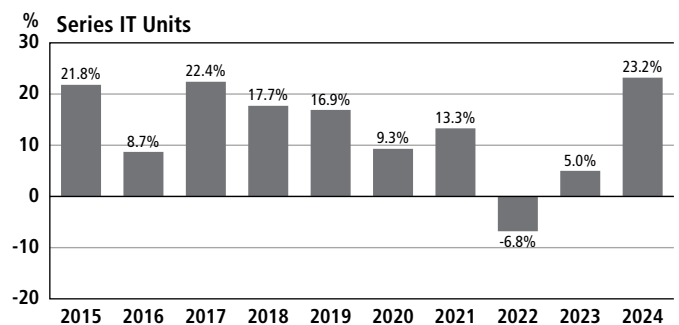
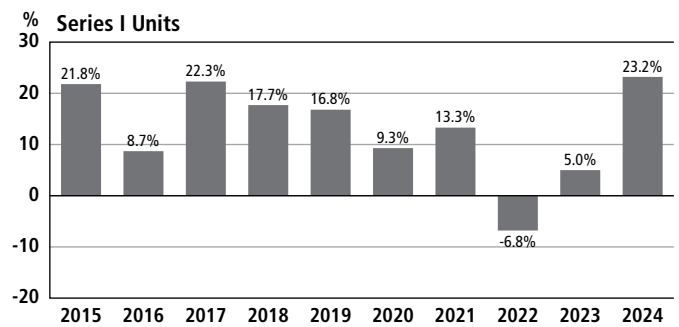
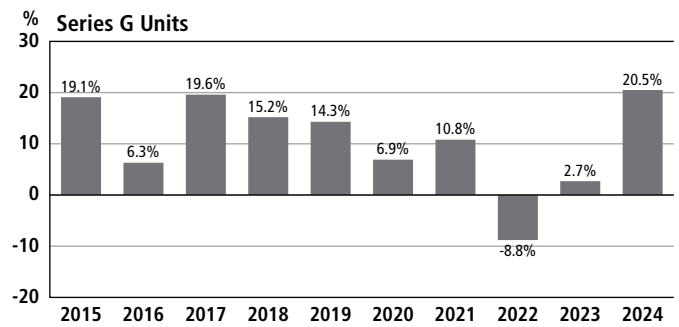
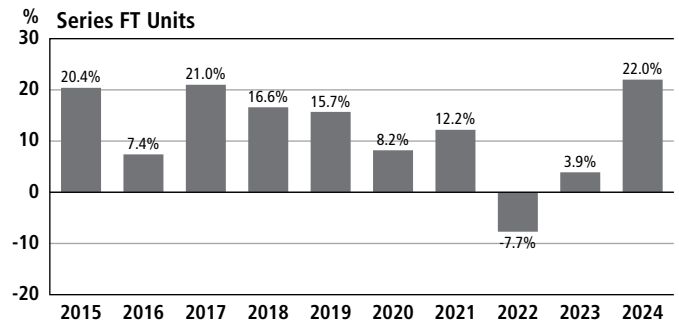
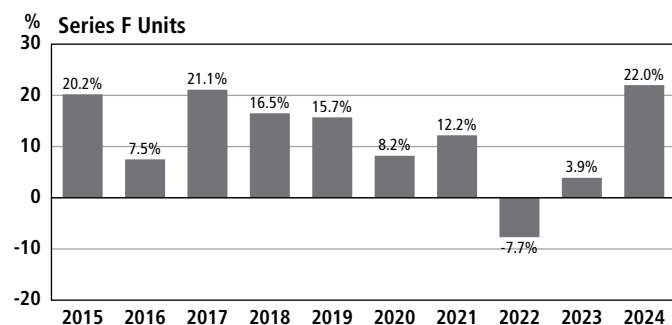
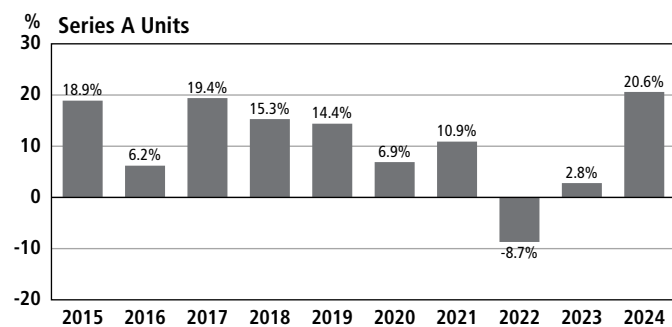
Past Performance

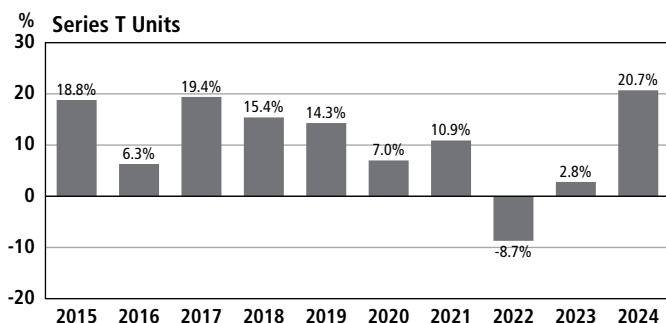
