The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Results of Operations

For the six-month period ended at December 31, 2024 (the "period"), the Series A units of the Fund generated a total return of 6.7%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmarks, the MSCI U.S. ESG Leaders Index and the MSCI Canada ESG Leaders Index (C\$) returned 11.3% and returned 19.7%, respectively, during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 30% MSCI Canada ESG Leaders Index (C\$) and 70% MSCI U.S. ESG Leaders Index returned 13.8%

during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

Consistent with the Fund's investment objective and strategies, during the period it invested in an actively managed and diversified portfolio of primarily North American equity securities of issuers who are engaged in the development of a sustainable economy. It is the Manager's view that a sustainable economy is one that strives to develop a future in which the environment, resource management and economic considerations are balanced in the pursuit of an improved quality of life. During the period the Fund invested in companies whose activities involved (but were not limited to): i) Sustainable energy generation such as renewable power, alternative fuels, carbon capture and storage and energy infrastructure. ii) Efficient consumption of energy such as electric transportation and supporting infrastructure, cleaner industrial production, efficient building design and construction and real estate development. iii) Responsible consumption and waste management such as consumer products and packaging, logistics and waste management companies that aim to mitigate environmental degradation, reduce physical pollution and improve resource efficiency. iv) Sustainable industry, infrastructure and communities such as telecommunications, infrastructure companies, utilities and real estate that seek to promote responsible industrialization, foster innovation and support resource-efficient economic development. v) Good health and well-being such as efficient and equitable food supply and healthcare and wellness companies that seek to promote healthier lives and wellness for the population.

The Fund underperformed the blended benchmark due in part to security selection in the Utilities sector and an underweight allocation to the Consumer Discretionary sector and security selection in the Information Technology sector and security selection in Communication Services sector. An underweight allocation to the Consumer Staples sector was a positive contributor to relative performance.

The U.S. equity market ended the 6-month period in positive territory as the S&P 500 Index (C\$) returned 13.9%. The second half of 2024 witnessed equity markets generate double-digits returns as the U.S. Federal Reserve (Fed) cut interest rates three times reducing the Federal Funds rate from 5.5% to 4.5%.

The economy expanded in the third quarter by 3.1% on an annualized basis. This was boosted by a surge in consumer spending. Pending home sales grew for the fourth straight month in November to return to the highest level since early 2023. What is noteworthy, inflation declined in the third quarter – from 2.9% to 2.4% – but crept back up to 2.7% in November.

Labor markets remain in a delicate equilibrium. Hiring rates are low, but so are layoffs. Income growth has supported strong consumption and Fed officials have been looking for signs that job growth is settling out at a pace that can hold the unemployment rate steady.

The Fed is trying to pull off a balancing act. They want to prevent the aggressive rate increases of the past two years from

unnecessarily slowing down economic activity, but they don't want to undo recent progress on inflation. Fed officials expect inflation to be stickier next year than anticipated.

All 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period. The best performing sectors were Consumer Discretionary, Financials and Utilities. The worst performing sectors were Materials, Energy and Health Care.

Over the period, the U.S. dollar strengthened against the Canadian dollar, Euro currency and British pound, while weakening against the Japanese yen.

The Canadian equity market ended the 6-month period in positive territory as the S&P/TSX Composite Index returned 14.7%. The second half of 2024 saw the Bank of Canada (BoC) cut interest rates four times that brought interest rates down 150 basis points from 4.75% to 3.25%.

Against this backdrop, easing monetary policy is starting to show in interest-rate-sensitive areas of the economy, with housing starts and sales of existing homes up the last two months after remaining lackluster for more than a year. The sharp interest rate cuts followed data showing Canadian GDP grew by an annualized 1% in the third quarter, below the central bank's projections of 2%.

Inflation has fallen to the central bank's target rate of 2%, it fell from 2.9% to 1.9% in November. Though, Canada's unemployment rate has risen to 6.8 per cent in November as the BoC says the number of people looking for work has increased faster than the number of jobs.

BoC Governor Macklem said 'the central bank isn't expecting a recession, though growth is slower than it had forecast.' He also said there was heightened uncertainty with the possibility that the incoming U.S. administration will follow through with threatened tariffs on Canadian exports.

Ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period. The best performing sectors were Information Technology, Financials and Utilities. The worst performing sectors were Communication Services, Industrials and Materials.

Over the period, the Canadian dollar weakened against most major currencies.

From a geographic perspective, the United States and Canada were positive contributors to returns, with the U.S. having a greater impact on performance. The sector exposure within the Fund is well-diversified, with Financials, Industrials and Information Technology representing the top allocations. Overall, most sector allocations saw marginal changes. Notable changes during the period included increase in Industrials holdings, while Communication Services holdings were lowered.

At a sector level and on an absolute return basis, Financials and to a lesser extent, Information Technology and Industrials were the largest contributors to performance with Utilities and Communication Services holdings detractors. Individual securities that were top contributors included Royal Bank of Canada, Brookfield Corporation and Salesforce Incorporated. Top

detractors included Northland Power Incorporated, BCE Incorporated and Granite Real Estate Investment Trust.

The Fund's net asset value increased to \$2.6 million at December 31, 2024, from \$2.1 million at June 30, 2024. This change was composed of net sales of \$0.4 million, and investment performance of \$0.1 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pays the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee

are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter, Cecilia Mo and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for

securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of

such securities and the 60-day period following the completion of such distribution;

- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

(2) The management expense ratio is based on the total expenses (including sales tax, and excluding commissions and other portfolio transaction costs) of each series of the Fund and a proportional share of underlying funds' expenses (mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.


Past Performance

The following shows the past performance for each series and will not necessarily indicate how the Fund will perform in the future.
