The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund seeks to achieve long-term capital growth primarily through investments in equity securities of businesses in the far east.

The Fund invests in equity securities of businesses located in, or with operations primarily based in, the far east which includes Australia, the People's Republic of China, Hong Kong, India, Indonesia, Japan, Malaysia, New Zealand, Pakistan, the Philippines, Singapore, Sri Lanka, South Korea, Taiwan, Thailand and Vietnam. Based on our view of the far east capital markets, the Fund may from time to time hold substantial investments in one or only a few of these countries.

Investment analysis for this Fund follows a bottom-up approach, which emphasizes careful company specific analysis. Using a value investment approach, this Fund invests in companies that represent good value based on current stock price relative to the company's intrinsic value.

All of the Fund's objectives and strategies are further described in the simplified prospectus of the Fund.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the

Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at June 30, 2025 (the “period”), the Series A units of the Fund generated a total return of 13.1%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund’s benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the “Past Performance” section for the performance of the Fund’s other series.

The Fund’s broad-based benchmark, the MSCI AC Asia Pacific Index (C\$) returned 14.7% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund’s performance relative to the general performance of the market.

International equities advanced over the 12-month period as the MSCI EAFE Index (C\$) returned 17.2%, the strongest 12-month return of the past five years. Developed markets continued to show the most strength with Japan, United Kingdom and Germany being the top performers.

The 12-month period has been one of profound transformation for global financial markets. Marked by fluctuating economic indicators, evolving monetary policy and shifting geopolitical landscapes, these developments have shaped the trajectory of equities, bonds and macroeconomic activity worldwide.

The global banking sector, after facing pressures from volatile interest rates and regulatory changes, has seen a cautious recovery. Major economies have had to deal with inflation, central banks’ tightening and easing cycles, and the persistent aftershocks of global supply chain disruptions. Central banks in the US, Europe and Asia initially maintained tight monetary policy in response to stubborn inflation, leading to higher short-term borrowing costs and restrained credit growth. Despite pockets of stress, most large financial institutions proved resilient, benefiting from robust capitalization and improved asset quality. However, regional banks in some markets, notably the United States and parts of Europe, faced liquidity concerns triggering regulatory intervention. The volume of cross-border lending and capital flows rebounded in late 2024 as confidence grew around the prospects of a “soft landing” for major economies. However, emerging markets continued to face volatility due to currency fluctuations and capital outflows.

Major U.S. indices reached new highs in late 2024, fueled by robust earnings from technology, artificial intelligence and renewable energy sectors. However, periods of volatility arose due to shifting expectations around Federal Reserve policy. Market breadth narrowed as gains became concentrated among the “Magnificent Seven” a label given to the largest tech stocks in the S&P 500 Index.

European equities delivered moderate gains, with the STOXX Europe 600 benefiting from stronger-than-expected economic data and resilience in industrials and luxury goods. The European Central Bank’s (ECB) cautious approach to rate cuts supported sentiment in early 2025.

Japanese equities outperformed, with the Nikkei 225 hitting multi-decade highs amid yen weakness and corporate reforms. Chinese markets struggled with sluggish economic growth, property sector woes and ongoing US-China tensions, although interventions by authorities in early 2025 stabilized investor sentiment.

Emerging market equities lagged developed peers, constrained by higher global interest rates, weaker currencies and recurring capital outflows. Latin America saw selective strength, particularly in countries with stable policy frameworks and commodity exposure.

With the exception of the Energy and Health Care sectors, all MSCI EAFE Index (C\$) GICS (Global Industry Classification Standard) sectors posted positive returns over the 12-month period, with Industrials and Financials being the largest contributors to index returns.

The Fund advanced on an absolute basis, however, underperformed the benchmark over the period. The largest contributors to absolute performance were the Fund’s holdings in the Financials, Consumer Discretionary and Information technology sectors while the largest contributors to relative returns were Consumer Discretionary, Information Technology and Health Care. The largest detractor from relative returns was the Fund’s security selection in the Financials sector.

The period’s top individual contributors included TSMC, Glodon, Tencent (Information technology), Sea (Communication Services), Alibaba, Trip.com (Consumer Discretionary), Samsung Biologics (Health Care) and BDO Unibank (Financials). The period’s individual positions which detracted included Unicharm (Consumer Staples), SMC (Industrials), Keyence, Samsung Electronics, Tata Consultancy Group (Information Technology), Reliance Industries (Energy), JD.com, Nitori Holdings (Consumer Discretionary) and Shenzhen Mindray (Health Care).

The Fund remains well diversified geographically, with China, Japan, India, Taiwan and Korea representing the largest country weights.

The Fund’s net asset value decreased to \$36.6 million at June 30, 2025, from \$42.0 million at June 30, 2024. This change was composed of net redemptions of \$10.7 million, and investment performance of \$5.3 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund’s income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund’s income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The

Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

Sub-Adviser Change

Effective October 30, 2024, Jarislowsky, Fraser Limited was appointed the sub-adviser to the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Related Sub-Adviser

The fund is sub-advised by Jarislowsky Fraser Limited, a related party to the fund. The Manager may pay a fee, which is negotiated with the sub-adviser, to the sub-adviser in respect of the investment advisory services provided to the Fund.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Cecilia Mo, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;

- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

(2) The management expense ratio is based on the total expenses (including sales tax, and excluding commissions and other portfolio transaction costs) of each series of the Fund and a proportional share of underlying funds' expenses (mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of

managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:

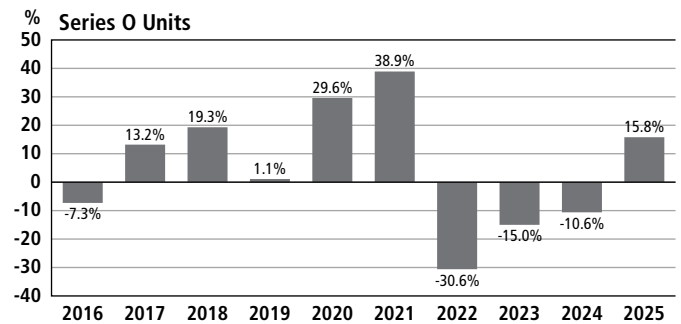
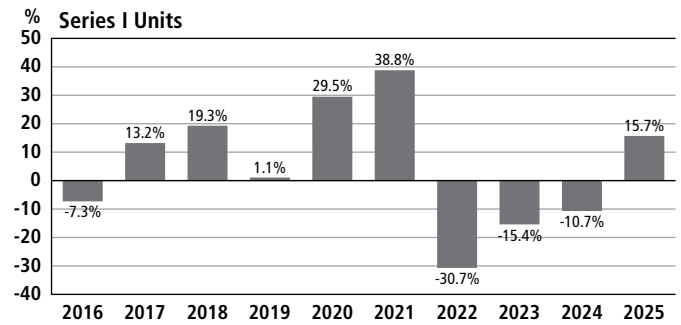
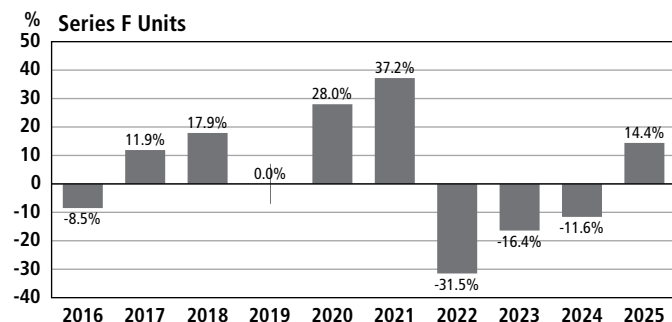
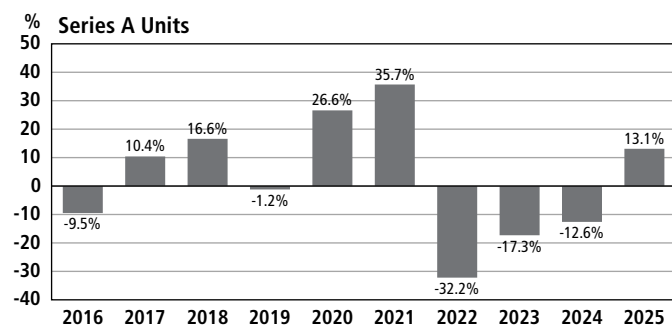
Past Performance

The following shows the past performance for each series and will not necessarily indicate how the Fund will perform in the future. The information shown assumes that all distributions made by each series of the Fund in the periods shown were reinvested in additional units of the relevant series. In addition, the information does not take into account sales, redemption, distribution or other optional charges that would have reduced returns or performance.

Year-by-Year Returns

The following charts show the performance for each series of the Fund and illustrate how performance has varied from year to year. The charts show, in percentage terms, how much an investment held on the first day of each fiscal year would have increased or decreased by the last day of each fiscal year for that series.

Annual Compound Returns

The annual compound returns table below compares each series of the Fund’s performance to one or more benchmarks. A benchmark is usually an index or a composite of more than one index. Fund returns are reported net of all management fees and expenses for all series, unlike the return of benchmarks which are based on the performance of an index that does not pay fees or incur expenses.
