The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund seeks to protect capital during a wide range of economic and market environments while earning superior risk-adjusted equity or equity related returns that are not correlated to major stock market indices.

The Fund will use alternative investment strategies primarily including engaging in physical short sales and may also include purchasing securities on margin or with borrowed funds. The Fund aims to reduce risk and invest in a diversified portfolio of equity securities from around the world.

All of the Fund's objectives and strategies are further described in the simplified prospectus of the Fund.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at June 30, 2025 (the "period"), the Series A units of the Fund generated a total return of 2.4%. Fund returns are reported net of all management fees and expenses for all series,

unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the HFRI Equity Hedge Index (C\$) returned 11.1% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

When the Fund makes investments in derivatives, borrows cash for investment purposes, or uses physical short sales on equities, fixed income securities or other portfolio assets, leverage may be introduced into the Fund. Leverage is measured by calculating the sum of the following: (i) the aggregate market value of the Fund's indebtedness; (ii) the aggregate market value of securities sold short by the Fund; and (iii) the aggregate notional value of the Fund's specified derivatives positions excluding any specified derivatives used for hedging purposes.

During the period, the Fund's aggregate exposure to these strategies ranged from 30% to 71%.

The Fund underperformed the benchmark during the period. Stock selection in the Information Technology and Financials sectors were key contributors to absolute performance. A short on the Vanguard S&P 500 ETF, (which is a hedge against market volatility) and stock selection in the Health Care sector were the primary detractors from performance.

The Fund is a global long/short fund. It invests primarily in U.S. and global equities but uses short positions both for alpha purposes and to hedge against market volatility. The Fund will in many cases have a significant cash position that is used to reduce volatility as the goal of the Fund is to protect capital and generate consistent, low volatility returns for its investors. By actively managing its long, short and cash positions, the Fund aims to generate positive returns regardless of the overall direction of the market. At period end, the Fund's cash position was approximately 49% and the Fund was gross long about 62%.

Short positions were employed and were used in two ways:

1) Alpha shorts – companies with deteriorating fundamentals are shorted to add alpha to the Fund; and 2) Beta shorts that are used as a hedge against market risk. The goal of the Fund is to provide market participation in terms of returns, with below market volatility. During the period, the Vanguard S&P 500 ETF was shorted as a hedge against market risk to assist in keeping volatility low. As the S&P 500 Index (C\$) returned 14.6% for the period, the short on the Vanguard S&P 500 ETF detracted from performance. The Portfolio Manager will increase or decrease the Fund's net exposure based on his thoughts on the markets and with the goal of keeping volatility low in the Fund. He has more than 23 years of experience managing this type of strategy.

At the start of the period (mid-year 2024), we tactically adjusted our positioning to market neutrality ahead of earnings season,

a move that protected the Fund during broad market sell-offs like the one witnessed in August where a rise in the yen unleashed an implosion in the macro hedge fund community which saw traders unwind an extremely crowded "carry trade" of short yen vs long U.S. dollar. This caused a stampede into VIX (volatility) futures as a form of protection and a pounding in the equity markets.

By late summer, as global economic data softened and central banks began their easing cycles, we increased net long exposure again, particularly in areas of secular growth like AI, software and housing. Our ability to capitalize on both long and short opportunities allowed us to generate positive returns, even as major indices faced periodic setbacks.

The sell-off that started post Presidents Day weekend (2025) in some of the best performing stocks in the market continued into March with much of the consternation coming from trade policy. The month began with a sharp sell-off triggered by sweeping new tariff announcements and retaliations. We had experienced periods of markets panicking before. We remained disciplined and grounded in our investment approach. We focused on trying to find companies with the potential to deliver significant revenue growth over the next five years or more.

Coming into April 2025, the Fund had a net long exposure of approximately 0%, with longs and shorts nearly balanced. This positioning was in preparation for earnings season and the April 2nd tariff announcements. While April 2025 was a month of extraordinary market volatility the Fund was able to protect the downside. By the end of the month, markets had regained much of their losses, buoyed by signals of easing trade tensions and a wave of better-than-expected corporate earnings, restoring confidence in the technology sector and the ongoing AI investment cycle.

The Fund delivered good performance in May. While it protected capital during April's downturn, it captured upside as markets recovered in May. We think that May's rally was driven by a confluence of positive factors: better-than-expected corporate earnings across key sectors, renewed confidence in technology stocks and continued momentum in the AI investment cycle. We believe this AI-driven transformation represents a multi-year opportunity with substantial runway ahead. The last month of the period was a good one for the Fund, driven by gains in technology and financial stocks. One of the biggest drag on performance during the second quarter of 2025 was Canadian dollar strength, which we believe is completely unsustainable.

Near the end of the period, we were on the road meeting with companies from all over the world. We came to the same conclusion as Eric Schmidt, former Google CEO, who said that AI is not overhyped, but rather "underhyped," because people do not fully grasp the scale and speed of the coming transformation. We believe the productivity boom we are about to witness will be significantly more important than anything in the 1990's.

Dynamic Alpha Performance II Fund has remained steadfast in its approach – combining deep fundamental analysis with active risk management. Our ability to navigate both long and short opportunities has allowed us to deliver good risk-adjusted returns, while attempting to position the Fund for continued success.

We do not make market predictions, nor do we use a top-down view to position our Fund. Our focus is always on the same investment process that has been at the core of our long-term success since we started this Fund in 2018 and the Dynamic Alpha Performance Fund in 2001.

The Fund's net asset value decreased to \$119.8 million at June 30, 2025, from \$121.2 million at June 30, 2024. This change was composed of net redemptions of \$4.3 million, and investment performance of \$3.2 million and cash distributions of \$0.3 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed

rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$1,000 in commissions to Related Brokers.

Performance Fees

The Manager is entitled to an annual performance fee based on the performance of the Fund as compared to the performance of a benchmark, as described in the Fund's simplified prospectus. Performance fees are calculated on a calendar year basis.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 –

Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Cecilia Mo, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager’s written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

[^] The MER includes the reversal of performance fees which were accrued in the NAV of the series in the prior fiscal period. Performance fees are accrued daily and paid on a calendar year basis, however the Fund's fiscal year is from July 1st to June 30th. As such, any performance fees accrued during the first half of the calendar year (January 1st to June 30th) will be included in the June 30th fiscal year end MER. If during the second half of the calendar year (July 1st to December 31st) the Fund's performance decreases or underperforms the benchmark, the performance fees may be reversed and will appear as a reversal of an expense in the Statements of Comprehensive Income, and will reduce the total expenses of the Fund or series, potentially resulting in a negative MER.

(2) The management expense ratio is based on the total expenses (including sales tax, and excluding commissions and other portfolio transaction costs) of each series of the Fund and a proportional share of underlying funds' expenses (mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

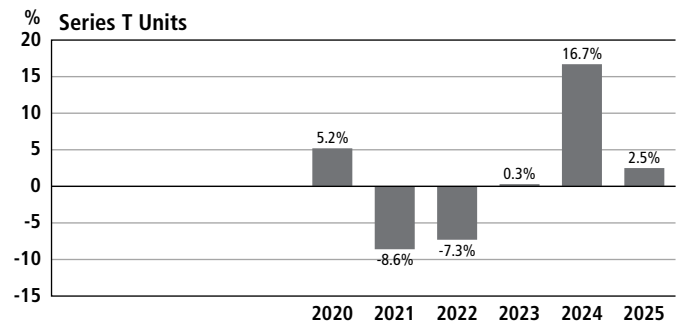

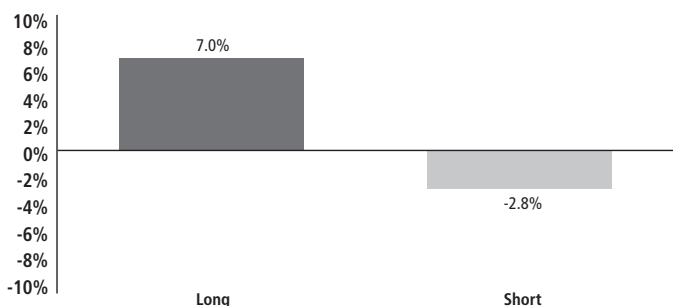
