#### Investment Objective and Strategies

The Fund's investment objective is to provide total returns that have lower correlations to major stock or bond market indices in the form of income and long-term capital appreciation by investing primarily in dividend-paying or distribution-paying equity securities.

All of the Fund's objectives and strategies are further described in the simplified prospectus of the Fund.

#### Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

#### Results of Operations

For the year ended at June 30, 2025 (the "period"), the Series A units of the Fund generated a total return of 15.4%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other

expenses that are applicable to that particular series. Please see the “Past Performance” section for the performance of the Fund’s other series.

The Fund’s broad-based benchmark, the S&P/TSX Composite Index returned 26.4% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund’s performance relative to the general performance of the market, but caution that the Fund’s mandate may be significantly different from the indices shown.

The Fund’s blended benchmark, 50% S&P 500 Dividend Aristocrats Index (C\$) and 50% S&P/TSX Canadian Dividend Aristocrats Index (C\$) returned 13.2% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

The Fund outperformed the blended benchmark due to an underweight and security selection in Consumer Staples and security selection in the Health Care and Consumer Discretionary sectors.

The Canadian equity market ended the 12-month period in positive territory. The Canadian economy navigated a path of moderate growth and disinflation, creating a supportive backdrop for equity markets.

The Canadian economy achieved a “soft landing”, with GDP growth remaining positive but subdued. Consumer spending held steady, and the labor market, while easing slightly, remained resilient with unemployment staying below 7.5%. Inflation steadily declined, reaching the Bank of Canada’s 2% target by early 2025, driven by falling energy prices and easing supply chain pressures.

This disinflationary trend allowed the Bank of Canada to cut interest rates twice in early 2025, bringing the policy rate into the 2.5%–3% range. These cuts improved financial conditions, lowered borrowing costs and boosted investor sentiment, particularly in rate-sensitive sectors like financials and real estate.

While business investment remained subdued, technology stocks outperformed and the broader economic environment – marked by low inflation, falling rates and stable growth – fuelled a strong equity market rally.

Ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 12-month period. The best performing sectors were Information Technology, Materials and Financials. The only negative performing sector was Communication Services.

Over the period, the Canadian dollar weakened against the Euro currency, British pound and Japanese yen, and remained flat against the U.S. dollar.

The U.S. equity market ended the 12-month period in positive territory as the S&P 500 Index (C\$) returned 14.6%. The period witnessed equity markets generate double-digits returns as the U.S. held presidential elections, inaugurated President Trump who announced tariffs to the world, while the war in Ukraine persisted and turmoil in the Middle East eased.

President Trump’s initial proposal of tariffs sent shockwaves to both equity and bond markets. The signal from the markets was that this would send inflation and interest rates up, weaken consumer and business confidence and trigger a recession. Though President Trump did dial back the tariffs from his initial proposal, tariffs did go into effect on Canada, Mexico and China, as well as on autos, steel and aluminum. This did have an impact on economic growth as the U.S. economy contracted at an annualized rate of 0.5% in the first quarter of 2025. This was largely driven by anemic growth in consumer spending and exports. This marks the first quarterly decline since 2022.

On the monetary side, the U.S. Federal Reserve (Fed) cut interest rates three times reducing the Federal Funds rate from 5.5% to 4.5%, from September to December. There have been no rate cuts yet in 2025 as Fed Chair Jerome Powell continues to gauge the effects tariffs will have on the inflation front. So far this year, inflation has gone from 3% in January to 2.4% in May, still above the Fed’s target rate of 2%.

Nine of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 12-month period. The best performing sectors were Financials, Utilities and Communication Services. The worst performing sectors were Health Care, Energy and Materials.

Over the period, the U.S. dollar weakened against the Euro currency, British pound and Japanese yen, and remained flat against the Canadian dollar.

The portfolio invests in a diversified portfolio of quality, income-generating companies from within a broad universe to generate a stable monthly income stream for investors in retirement or pre-retirement. At the end of the period the Fund’s largest allocations were in Canada and the U.S. The weighting to Canada saw an increase as the U.S. was lowered. Both Canada and the U.S. were positive contributors to returns, with Canada having more than double the impact on performance.

The Fund’s asset mix remained invested primarily in Canadian equities and to a lesser extent the U.S. with both allocations lowered over the period. In the alternatives component the exposures to LRCNs/Institutional Preferreds and mortgage REITs were increased and a position in Dynamic Real Estate & Infrastructure Income II Fund was added to the portfolio. The weighting in options writing notably rose to a low double digit level, offering an attractive income stream. Holdings in Dynamic Short Term Credit PLUS Fund and the allocation to freely tradeable cash were decreased.

The sector allocation within the Fund is diversified, with Financials, Energy and Real Estate representing the top weightings. Sector changes undertaken included an increase to Health Care and Financials with Energy, Materials and Communication Services decreased. Financials, Energy and Real Estate were the top contributors to performance with Information Technology a small detractor at the sector level. Holdings in LRCNs/Institutional Preferreds and Dynamic Short Term Credit PLUS Fund also had a positive impact on returns. Individual equity securities that were top contributors included Sienna Senior Living Inc. and Toronto-Dominion Bank. Positions in BCE Inc. and Alphamin Resources Corporation, which detracted from performance, were sold.

The Fund's net asset value increased to \$191.7 million at June 30, 2025, from \$178.9 million at June 30, 2024. This change was composed of net redemptions of \$9.1 million, and investment performance of \$29.5 million and cash distributions of \$7.6 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments and changes in fixed administration fees.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

## Recent Developments

### **Management Fee Reduction**

Effective May 1, 2025, the management fee charged was reduced from 1.75% to 1.70% for Series A and Series H units and reduced from 0.75% to 0.70% for Series F and Series FH units of the Fund.

### **Fixed Administration Fee Change**

Effective May 1, 2025, the fixed administration fee charged to Series O units of the Fund was reduced from 0.07% to 0.05%.

### **Fund Mergers**

On July 18, 2025, Dynamic Active Retirement Income ETF (the "Terminated Fund") merged into the ETF Series of the Fund. As a result of the merger, the Fund acquired all the net assets of the Terminated Fund at fair market value in exchange for shares of the Fund and the securityholders of the Terminated Fund became securityholders of the Fund. Except for an increase in net assets, there was no material impact to the Fund.

## Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

## **Management Fees**

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

## **Fixed Administration Fees and Fund Costs**

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

## **Related Brokerage Commissions**

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$23,000 in commissions to Related Brokers.

## **Distribution Services**

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

## **Other Fees**

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn

a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

### **Independent Review Committee**

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Cecilia Mo, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

### **Financial Highlights**

The following tables show selected key financial information about each series of the Fund and are intended to help you understand the Fund’s financial performance for the periods indicated. The information on the following tables is based on prescribed regulations and as a result, is not expected to add across due to the increase (decrease) in net assets from operations being based on average units outstanding during the period and all other numbers being based on actual units outstanding at the relevant point in time. Footnotes for the tables are found at the end of the Financial Highlights section.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager’s written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

## Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

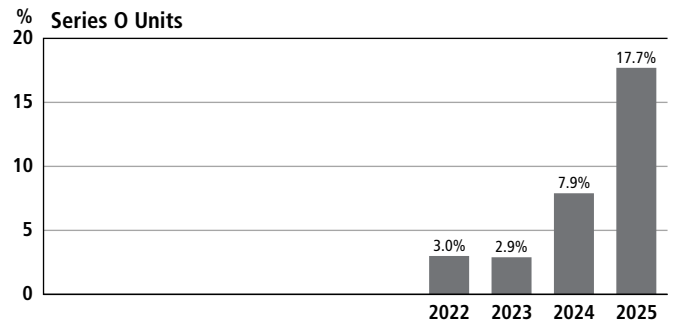
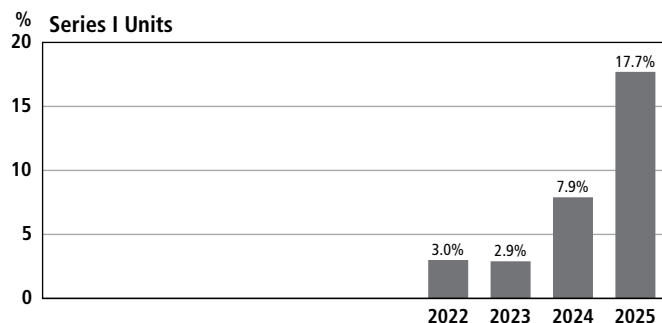
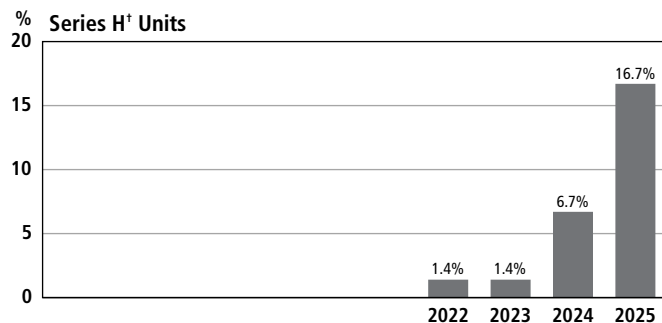
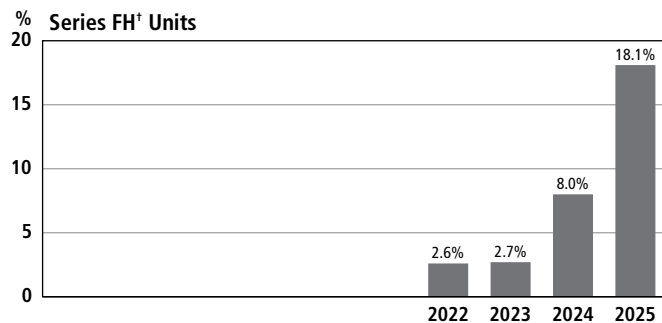
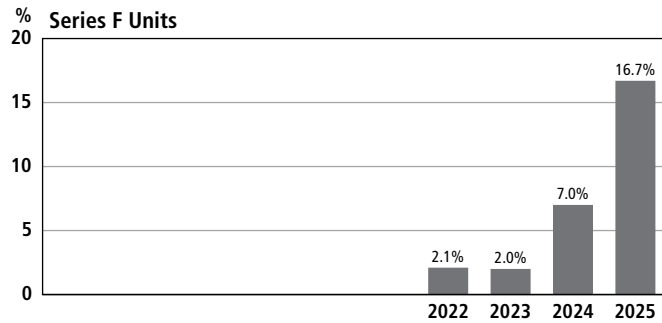
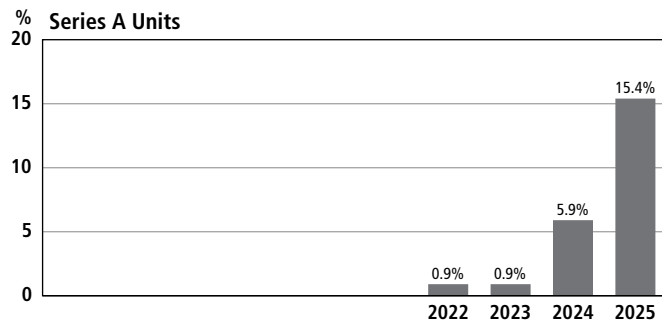
## Past Performance

### Index Descriptions

S&P/TSX Canadian Dividend Aristocrats Index (C\$) – This index measures the performance of companies included in the S&P Canada BMI that have followed a policy of consistently increasing dividends every year for at least five years. Index constituents are weighted according to their indicated yield as of the last trading date in November.

S&P 500 Dividend Aristocrats Index (C\$) – This index measures the performance of large cap, blue chip companies within the S&P 500 that have followed a policy of increasing dividends every year for at least 25 consecutive years.

S&P/TSX Composite Index – This is a broad economic sector index comprising approximately 95% of the market capitalization for Canadian-based, Toronto Stock Exchange listed companies.
