1832 Asset Management L.P. is the manager (the "Manager") of the Fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Dynamic Integrated Balanced Growth Class Portfolio.

The term "net asset value" or "net asset value per share" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per share" refers to total equity or net assets attributable to shareholders of the Fund as determined in accordance with IFRS Accounting Standards.

Results of Operations

For the six-month period ended at December 31, 2025 (the "period"), the Series A shares of the Fund generated a total return of 5.7%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

To achieve its long-term asset allocation mandate, the Fund invested directly in fund(s) managed by the Manager or by third party investment managers ("Underlying Fund(s)"). As a result the following commentary on investment portfolio activity relates to the Underlying Fund(s). Commentary on income, expenses and shareholder activity relate to the Fund.

The Fund's broad-based benchmarks, the S&P/TSX Composite Index, Solactive GBS Developed Markets Large & Mid Cap Index (C\$) and the FTSE Canada Universe Bond Index returned 19.5%, 11.6% and returned 1.2%, respectively, during the same

period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 20% S&P/TSX Composite Index, 35% FTSE Canada Universe Bond Index and 45% Solactive GBS Developed Markets Large & Mid Cap Index (C\$) returned 9.4% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

The Fund has a long-term asset allocation of 20% Canadian equities, 45% global equities and 35% bonds. During the period, the Fund underperformed its blended benchmark, primarily due to the Canadian and global equity components lagging their respective benchmarks.

The Canadian bond market, as represented by the FTSE Canada Universe Bond Index, returned 1.2% for the 6-month period ending December 31, 2025. The 10-year Government of Canada yield rose as high as 3.6% in July before falling to 3.0% in November. It ultimately ended the period at 3.4%. After holding the policy rate steady for 3 consecutive meetings, the Bank of Canada (BoC) resumed its rate cutting cycle with a 25 basis points (bps) rate cut in both September and October. In the United States, the 10-year Treasury yield dipped down to 3.9% in October before rising to 4.2% to end the year. Following the volatility of the period after the Trump Administration's "Liberation Day" announcements, bond markets experienced a relatively more stable period. The Federal Reserve resumed its own easing policy with three 25 bps cut in the second half of the year after keeping rates steady earlier in the year. These cuts reduced the key policy rate to 3.75% at year end. The Federal Reserve's path was guided by weaker economic and jobs data. Investment grade credit spreads, as measured by ICE BofA Canadian corporate indices OAS (Option-Adjusted Spread) remained in a relatively tight range for the duration of the period. After the volatility earlier in the year, strong corporate fundamentals and demand for debt (specifically Investment Grade) resulted in more stable market conditions and tighter spreads.

Within the Fund's fixed income component, 1832 AM Global Credit Pool, Dynamic High Yield Bond Fund and Dynamic Total Return Bond Fund outperformed, while Dynamic Canadian Bond Fund performed in line with the FTSE Canada Universe Bond Index. All mandates contributed to performance.

During the period, Dynamic Active Bond ETF, Dynamic Active Tactical Bond ETF and Dynamic Corporate Bond Strategies Fund were added to the portfolio. Overall, the combined weighted-average results of the Fund's fixed income holdings were in line with the FTSE Canada Universe Bond Index.

The Canadian equity market ended the six month period in positive territory, with the S&P/TSX Composite Index returning 19.5%. The index rose meaningfully, driven by stronger commodity prices and a supportive policy setting, despite modest real economic growth.

The Bank of Canada resumed its rate cutting cycle, including an October move that lowered the policy interest rate to 2.25%. While debate persisted about the pace of further reductions, easier policy helped anchor valuations and lift risk appetite in interest rate sensitive segments of the market.

At the same time, inflation moderated and labour markets softened, with banks flagging rising delinquencies and credit losses – signals of a cooler domestic backdrop. U.S. tariff hikes announced in April remained a source of volatility, with periodic negative headlines. However, exemptions under the Canada–United States–Mexico Agreement (CUSMA) kept most Canadian exports duty free. The elevated tariff environment sharpened the focus on cross border demand and pricing power, influencing earnings expectations for exporters and import competing industries.

In summary, the second half of 2025 was marked by strength in precious and base metals – especially gold – supporting the Canadian resource heavy index. The new federal government in Ottawa has been working to attract foreign investment and diversify trade beyond the U.S.

Ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the six month period. The best performing sectors were Materials, Financials and Information Technology. The only negative sector was Industrials.

Over the period, the Canadian dollar slightly weakened against the U.S. dollar, remained flat against the euro and strengthened against the British pound and Japanese yen.

The Fund's Canadian equity holdings underperformed the S&P/TSX Composite Index and detracted from performance. These included Dynamic Dividend Advantage Fund, Dynamic Equity Income Fund, Dynamic Power Canadian Growth Fund, Dynamic Small Business Fund and Mackenzie Bluewater Canadian Growth Fund.

As part of a strategic re-optimization, the Fund added positions in the Scotia Wealth Quantitative Canadian Small Cap Equity Pool, 1832 AM Canadian Growth LP, 1832 AM Fundamental Canadian Equity Pool and Dynamic Active Canadian Dividend ETF. Overall, however, the combined weighted average of the Fund's Canadian equity holdings underperformed the index over the period.

Global equities advanced over the 6-month period as the MSCI World Index (C\$) returned 11.5%. The second half of 2025 can be characterized as a reversal of fortune from the first half as investors had a risk on sentiment and witnessed equity markets rallying double digits over the period.

While inflation concerns remain elevated, fears of a tariff-driven price spike similar to 2022 proved unfounded and central banks were able to continue normalizing interest rates.

The U.S. economy expanded at an annual rate of 4.3% in the third quarter, the highest growth rate in two years. Despite a resilient economy with strong GDP growth, the labour market struggled as the unemployment rate inched up to 4.4%, leading the U.S. Federal Reserve (Fed) to cut interest rates three times over the period from 4.50% to 3.75%, which is now at a three-year low.

In the Eurozone, investor confidence was bolstered by the continued Fed rate cuts, which helped ease global financial conditions and reduce risks for European assets. Economic conditions across the eurozone remained mixed. Manufacturing activity, especially in Germany, continued to contract and that negatively affected export focused sectors. Services activity stayed strong, however and that helped overall business activity expand modestly. The European Central Bank kept policy rates unchanged for the period, while vowing to maintain a careful watch on growth and price trends.

Emerging markets was one of the top-performing regions. Equity gains were mainly driven from the technology-oriented markets of South Korea and Taiwan.

Precious metals were the standout asset class for the period. Gold dominated the headlines as international central banks continued to diversify their reserve holdings into the precious metal.

All 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period, with Communication Services, Materials and Health Care being the largest contributors to index returns. The worst performing sectors were Real Estate, Consumer Staples and Industrials.

Among the Fund's global equity holdings, performance compared to the Solactive GBS Developed Markets Large & Mid Cap Index (C\$) was mixed. RBC Emerging Markets Equity Fund, Dynamic Global Equity Fund and Dynamic Power American Growth Fund performed in line, while Dynamic Global Dividend Fund, Dynamic Global Infrastructure Fund, Mackenzie Global Dividend Fund, Manulife World Investment Class and Mawer U.S. Equity Fund underperformed and detracted from performance.

As part of a strategic re-optimization, the Fund added positions in the 1832 AM Emerging Markets Equity Pool, Scotia U.S. Equity Index Tracker ETF, Scotia Wealth Fundamental International Equity Pool and Scotia Wealth Quantitative Global Small Equity Pool. Overall, however, the combined weighted average of the Fund's global equity holdings underperformed the index over the period.

In November, the Fund underwent a merger and program renaming, transitioning from the Marquis Portfolio Solutions structure to the Dynamic Integrated Portfolios. These changes did not affect the Fund's investment objectives or strategies but resulted in updated fund names and the consolidation of certain underlying holdings.

In December, the Fund's strategic asset allocation was updated to reflect a 10% increase in equity exposure. At the end of the month, the Fund also expanded its strategic toolkit by introducing a range of alternative investments: Dynamic Diversified Private Assets Fund, 1832 AM Institutional Private Credit Fund, 1832 AM Institutional Private Real Estate Fund and 1832 AM Institutional Private Equity Fund.

The Fund's net asset value decreased to \$37.5 million at December 31, 2025, from \$38.0 million at June 30, 2025. This change was composed of net redemptions of \$2.6 million, and investment performance of \$2.1 million. The investment performance of the Fund includes income and expenses which

vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments and changes in fixed administration fees.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

Fixed Administration Fee Change

Effective November 14, 2025, the fixed administration fee on Series A, F, I and T units of the Fund was reduced from 0.12% to 0.07%.

Fund Name Change

Effective December 5, 2025, the Fund was renamed from Marquis Balanced Growth Class Portfolio to Dynamic Integrated Balanced Growth Class Portfolio.

Fee Reductions

Effective December 5, 2025, the management fee on Series A and T units of the Fund was reduced from 2.00% to 1.70%. Series F units of the Fund was reduced from 1.00% to 0.70%.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the “Fixed Administration Fee”) to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund’s financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund’s most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses (“Fund Costs”). Further details about Fund Costs can be found in the Fund’s most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series’ expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a “Related Broker”). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$1,000 in commissions to Related Brokers.

Distribution Services

Certain registered dealers through which shares of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when shareholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it

by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Cecilia Mo, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;

- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions

require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and calculated and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:

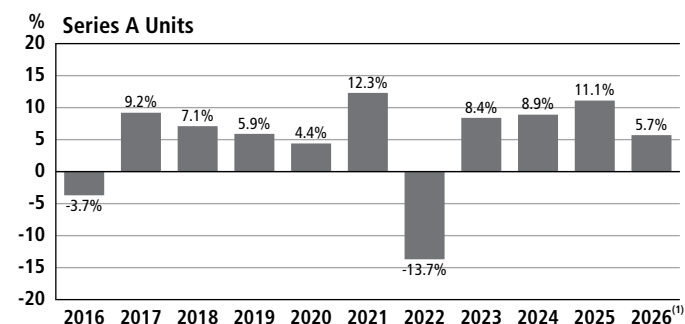

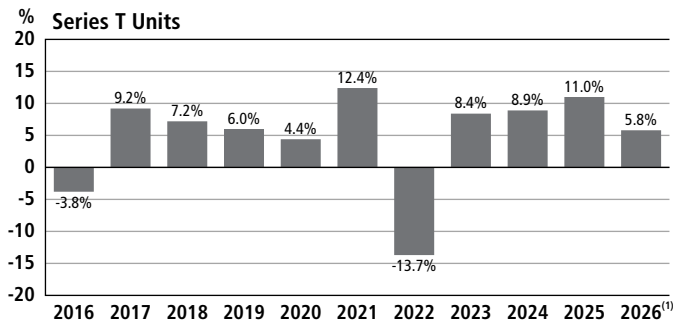
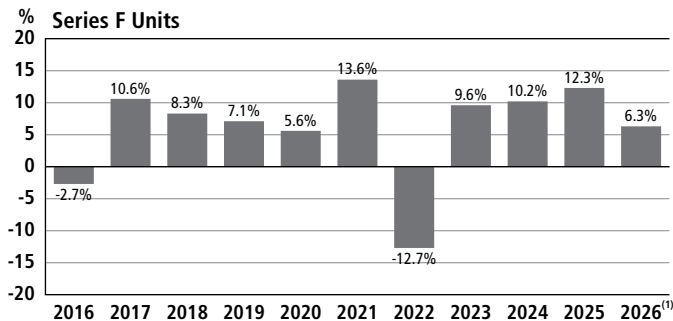
